THE ORIGINAL PINKY SWEAR PROMISE

Mitch Chepokas was nine years old when he was diagnosed with bone cancer. When he was in the hospital in December, he overheard the family next to him having a discussion that there would not be enough money for Christmas that year.

Mitch looked at his dad Steve, and said, "This isn't fair. How much money do I have in the bank?" Steve helped Mitch into his wheelchair and took him to the bank. Mitch withdrew all the money he had in his savings account and put it in envelopes for the kids on the pediatric oncology floor at the hospital. He signed each envelope, "Love Mitch, XOXOXO."

Before Mitch passed away, he made a pinky swear with his dad to continue to help kids with cancer and their families. Since his death in 2003, together with our supporters, Pinky Swear Foundation has provided more than \$21.5 million in financial assistance for families.



Za'nari was a lively toddler when her world was turned upside down just before her third birthday. After returning from vacation, Cece noticed lumps on her daughter's neck. A visit to the doctor led to a diagnosis: acute lymphoblastic leukemia (ALL).

Za'nari's journey included losing her hair, a port for medicine, and long hospital stays. It was overwhelming. Cece and Za'nari's dad, Hakeem, faced significant challenges navigating Za'nari's cancer treatment, a newborn, and supporting their family. Cece stopped working to care for Za'nari and their newborn son, Zaire, while Hakeem worked extra hours.

Despite the difficulties, they found strength in each

other and remembered the little things like Za'nari's smiles when they packed her favorite toys and snacks for the hospital. They also found support from Pinky Swear Foundation.

Cece reflected on a care package from Pinky Swear with colored pencils, Play-Doh, and gift cards. It made Cece feel less alone and brought joy to Za'nari. The gift card for gas and a rent payment allowed Hakeem to spend more time at home and at the hospital with his family.

The family celebrated Za'nari's last chemotherapy treatment in April 2024. She will start kindergarten this fall and will bring joy to every room she is in.

"We were most grateful for organizations like Pinky Swear that were there to support us, and for the doctors, and everyday things like having a vehicle and a roof over our heads and ensuring there was food for me and the children." Cece said.
