We invite you to read this year's annual report with pride. Join Pinky Swear in celebrating the strength and resilience of the children and families we serve, and the vital support made possible by you.



Nine-year-old Mitch Chepokas' legacy is about more than his terminal bone cancer. It is about a young boy with a generous spirit who loved baseball.

While in the hospital for cancer treatment, Mitch overheard another family talking about not being able to afford Christmas presents. Mitch withdrew \$6,000 from his savings account, given to him throughout his cancer journey, and gave it away to other kids in the hospital. Mitch enjoyed the act of giving so much that he made his dad pinky swear promise to continue helping families even after he passed away.

And because of the inspiration created by a young boy's big heart, the Pinky Swear Foundation was formed to carry out Mitch's mission and fulfill that unbreakable promise.

To this day, in honor of Mitch and his love for baseball, Pinky Swear Foundation refers to all children with cancer and their families as All-Stars.

Pinky Swear Pantry

On-site food pantries at children's hospitals so that families can keep nourished without having to leave their child's bedside during cancer treatment.

KIDS HELPING KIDS

Pinky Swear Foundation is built on the inspiration of kids helping kids. Today's programs include:

- The Charles M. Harper Youth Leadership Council builds awareness with their middle and high school peers, fundraises and spreads a national movement.
- The PACK (Pinky Swear Ambassadors on College Campuses to Help Kids with Cancer) Program was founded in 2020 to connect college students with childhood cancer patients and exists at over 175 colleges.
- A Student Scholarship Program celebrates student leaders supporting kids with cancer. The 10 recipients in 2020 raised over \$405,000 and gave 74 Pinky Swear Foundation volunteer hours.



YOU MADE 2020 A RECORD BREAKING YEAR

Pinky Swear Foundation and families battling childhood cancer have one million reasons to thank you for making 2020 a record-breaking year.

Because of generous partners like you, over \$1 million was given away directly to families. You helped pay mortgages, rents, auto expenses, utilities, groceries, gas, and so much more. Above all, you gave parents the invaluable gift of being able to spend more time with their child battling cancer.

One family in particular made a large impact in 2020, as the journey is personal to them...

Close to five years ago, Tim and Lucy Reinhardt lost their son, affectionately known as Super Cal, to brain cancer. Fortunately, with employers who gave them time off and plenty of other support, Tim and Lucy were able to spend the last month of Cai's life together as a family at home. Lucy said, "We helped write that last month of his life. You have no idea how important it is to be able to say goodbye to somebody...it's overwhelming."

Throughout the Reinhardt's cancer journey, they continued to lean on the support of family and friends like Lance Larson, a trustee of the David and Janis Larson Foundation. "When I did talk to Tim and Lucy, one of the things that came across loud and clear was their thought and concern about other children that were there [battling cancer in the hospital] that didn't have visitors – didn't have family. I couldn't absorb that. I couldn't figure it out," said Lance. He discovered time away from work is not an option for most families. "To have the choice between paying your mortgage, putting food on the table, being with your child, having fuel in your car to go see your child at the hospital... that becomes the choice in and of itself," said Lance.

This realization led Lance and his brother, Reid, to seek a way the David and Janis Larson Foundation could give families valuable time with their child. Lance said, "I asked Tim and Lucy about us creating an endowment in Cal's

name. There are all sorts of things for research...but I didn't know if there was anything that can allow families to focus on the biggest fight of their lifetime." During this time, Lance heard about Cal being an All-Star at Pinky Swear Foundation, and he gave Erica at Pinky Swear Foundation a call. "A light of my life, a relationship began in that phone call," said Lance.

And from that phone call, Pinky Swear Foundation and the David and Janis Larson Foundation formed a beautiful partnership. Now the David and Janis Larson Foundation is providing matching funds for gifts given toward the goal of creating a \$10 million Pinky Swear Foundation Endowment Fund.

College students in this program are involved in spreading awareness of the impact of childhood cancer and helping raise funds to provide support to these families through Pinky Swear Foundation.

Pinky Swear Foundation is excited to highlight one of the first members of Pinky Swear Foundation's PACK Program, Sabrina Genovese. As a student at State University of New York at Buffalo, Sabrina served as the PACK President on her campus. Because of her leadership, vital support was provided to over 50 children with cancer and their families.

"It is still shocking . . . that my PACK was able to make this large of an impact," Sabrina said. "We wish to hug and thank the families we helped during this time, though just knowing that we have helped them is far more than enough."

Sabrina graduated from PACK but her impact through the program will last a lifetime for those she helped.
